From Chicago

Take 94 north to exit Rt. 137(Buckley Road) east
East on Rt. 137 to North Chicago VA Medical Center, next stop light after Green Bay Road (Lewis & Rt. 137)

From Wisconsin

Take 94 south, exit Hwy. 41 (Waukegan)
Continue south and exit Rt. 137 (Buckley Road) east
East on Rt. 137 to North Chicago VA Medical Center, next stop light after Green Bay Road (Lewis & Rt. 137)

▲ SHUTTLE SERVICE

Shuttle bus service will operate on normal workdays
